Methods: The data presented in this fact sheet were collected as part of the California Healthy Kids Survey in the 2015-2016 academic year at middle and high schools across Contra Costa County. The data were collected using a paper and pencil survey administered by school sites and reported to and compiled by WestEd. Kris De Pedro, Ph.D. at Chapman University, the ACLU of California, and John Elfers, PhD. at Sofia University requested the dataset from WestEd. The data were analyzed running Chi-Square tests using SPSS statistical software. All differences reported here are statistically significant. The California Healthy Kids Survey was developed by WestEd under contract to the California Department of Education. This fact sheet was prepared by Kris DePedro, PhD at Chapman University in collaboration with the Central Coast Coalition for Inclusive Schools and the American Civil Liberties Union (ACLU) of California.
